Information Required for Rehabilitation /Reconstruction Loan Application

All information listed and the application package must be complete.

*****After completed, call to make an appointment to bring the package in and sit down with a loan representative at 750-5656.*****

1. Copy of Drivers License or picture I.D. on everyone in the home over 18 years of age and Social Security Cards on all household members.
2. If you are not an U.S. Citizen, we will need a copy of your U.S. Immigration Permit. (Green Card/Pink)
3. Current employment: Full and part-time—Latest year-to-date pay stubs totaling at least 30 days. (We will need a written explanation for any payroll deduction that does not appear to be taxes, retirement plans or health insurance. Please make sure you list on your loan application those debts that are payroll deductible.)
4. Copy of the last two years W-2 forms and Tax Returns with all schedules attached!
5. SELF-EMPLOYED: Need a current year-to-date Profit and Loss Statement signed and dated-certifying that all information is true and correct to the best of your knowledge. Will also need business tax returns for the last two years. If you are a Partnership, we will need the Partnership returns for the last two years. If you are a Corporation or S Corporation, we will need those returns for the last two years.
6. If you have retirement income or disability income, we will need proof of Retirement/Social Security income. Award letters, copies of checks, etc.
7. Document any other income received (rents, royalties, alimony, child support, public assistance, etc.)
8. Copies of the last three months bank statement, with all pages.
9. Verification of Mortgage and / or Rent – We need to verify two years residency. Be sure all Mortgage Company and Landlord information is available. (Address, phone numbers and account numbers, if applicable).
10. Divorce Decree, if applicable
11. MISCELLANEOUS DOCUMENTATION: Certain documents will be required to show proof of child support, sale of real estate, proof of real estate ownership w/o liens, etc.
12. If you are applying for a Rehabilitation loan, you will be required to show current insurance and proof that the property taxes are paid.
13. Proof of ownership – copy of Deed – applicant must be shown as the owner on the deed. The City will order a title commitment on the property. If the title commitment does not show the proposed borrower(s) as the owner of the property, and the Title Company requested additional information such as an Affidavit of Heirs, Probated Will, General Deed in place of a Quit Claim Deed, etc., your application will be denied if the title issues have not been cleared up within 30 days from the date of the title commitment. After you have cleared up any title problems, check with us to see when our next application process will begin and you may re-apply.
14. Proof of Residency-current water bill and current electricity bill-You will also be required to sign an Affidavit of Residency.
15. Application must be signed by all parties and initialed at the bottom of each page, if applicable.

Please remember the following:

- ◆ The home must be in the City Limits of Waco.
- ◆ The **household income** cannot exceed 80% of the median income of Waco by household size.
- ◆ The Loan Committee must approve the City of Waco loan.
- ◆ Borrower must make an investment into the property based on household income:
 - 30% or less of median - \$0
 - 31-59% of median - \$500
 - 60-80% of median - \$1,000
