Additional Notice of Wastewater Discharge

Waco, Texas (May 27, 2016) – Due to substantial rainfall, unauthorized discharges of wastewater have occurred from the City of Waco Wastewater Collection System. These discharges are in addition to the discharges that began and ended yesterday (5/26).

The discharges, totaling approximately 297,050 gallons of domestic wastewater, occurred and/or are occurring at 1502, 1100 and 400 University parks Dr., 1000 Trice Ave., 916 Valley Mills Dr., 810 N. 31st St., 1916 N. 12th St. and three locations around 7909 Skeet Eason Rd.

Area potentially affected: area around manholes located at 1502, 1100 and 400 University parks Dr., 1000 Trice Ave., 916 Valley Mills Dr., 810 N. 31st St., 1916 N. 12th St. and 7909 Skeet Eason Rd. and the Brazos River around the area of 1502, 1100 and 400 University parks Dr.

Suspected cause of spill(s): substantial rainfall infiltrating collection system

List of actions taken include, but are not limited to:

- Notification of appropriate local government officials
- Notification of TCEQ Regional Office
- Clean-up activities are underway / completed.

THIS IS NOT A BOIL WATER NOTICE. The information below includes mandatory health safety statements required by the Texas Commission on Environmental Quality. The city's wastewater collection system is completely separate from the drinking water system and **the City of Waco has no reason to believe drinking water, distributed by the City of Waco, has been compromised or affected in any way.**

Persons May Wish to Take the Following Personal Precautions:

- Persons using private drinking water supply wells located within ½ mile of the spill site or within the potentially affected area should use only water that has been distilled or boiled at a rolling boil for at least one minute for all personal uses including drinking, cooking, bathing, and tooth brushing. Individuals with private water wells should have their well water tested and disinfected, if necessary, prior to discontinuing distillation or boiling.
- Persons who purchase water from a public water supply may contact their water supply distributor to determine if the water is safe for personal use.
- The public should avoid contact with waste material, soil, or water in the area potentially affected by the spill.

- If the public comes into contact with waste material, soil, or water potentially affected by the spill, they should bathe and wash clothes thoroughly as soon as possible.
