PUBLIC MEETINGS REGARDING PROPOSED TRANSPORTATION PROJECTS

WACO – The Waco Metropolitan Planning Organization (MPO) will be conducting a series of 3 public informational meetings beginning tomorrow for the public to review and comment on proposed changes to Connections 2040, the Waco Metropolitan Transportation Plan (MTP) and the draft 2017-2020 Transportation Improvement Program.

The MTP outlines the transportation needs for the Waco Metropolitan Area through the year 2040 and identifies the projects proposed to address these needs. The TIP identifies those projects for which funds have been committed to begin engineering studies, right of way acquisition, construction or project implementation during the TIP timeframe.

ADDITIONAL OPPORTUNITY FOR PUBLIC TO VOICE ANY TRANSPORTATION CONCERN

In addition to the opportunity to review and comment on these documents, the MPO would like to invite the public to discuss any transportation issue or concern with MPO staff at these meetings. No topic will be off limits as long as it's related to transportation. All concerns raised will be forwarded to appropriate agencies and will be followed-up by MPO staff.
