

## Waco MPO to Host Public Informational Meetings on TIP

The Waco Metropolitan Planning Organization is soliciting comments regarding a proposed amendment to the 2015-2018 Transportation Improvement Program.

The [Transportation Improvement Program](#) (TIP) is a list of federally funded highway or transit projects scheduled for implementation within the Waco Metropolitan Area during fiscal years 2015 to 2018. Proposed Amendment One widens Loop 340 to four lanes divided and constructs a bridge over the Brazos River. The project limits are from the Brazos River to SP 484 / SH 6.
