4. A scaled site plan for each sign and drawings of the lot indicating the location of the proposed signage.
5. A overall plan showing the location and size of existing signage in relation to new signs.
7. For detached signs that are 35 feet or higher drawings with professional engineers seal must be provided with this application.

Please attach photos or other documents that may assist with the processing of this application.

Important: After the installation of the sign is complete, a final inspection of each sign will be made based on the information provided on this form. Signs that are not installed to the specifications provided herein are subject to enforcement actions by the Planning Services Department; up to and including removal of the sign.
