4. **Review and Discussion** regarding 2010 traffic counts and traffic trends for the Waco Metropolitan Area.

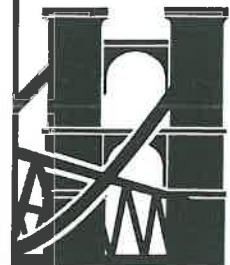
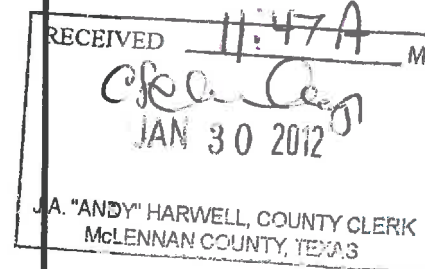
