- 1.) **Who is your current vendor for fuel?** – RKA Petroleum
- 2.) **What is your current Fuel contract's pricing structure?** – Freight, pump-off charge (if applicable) & constant mark-up. However, the pump-off charge will NOT be paid if a pump is available at the fueling site.
- 3.) **Will all deliveries be a full load, or will some be via tank wagon?** - All will be full loads except in the event of an emergency. In that case, split loads may be requested.
