

Annual Listing of Projects Federal Obligations for FY 2022

Purpose

To meet the requirements of the Federal surface transportation acts: "Fixing America's Surface Transportation (FAST)" Act, and the "Infrastructure Investment and Jobs Act (IIJA)", the MPO produces the following list of projects for which federal highway or transit funds were obligated within the Waco Metropolitan Area during Fiscal Year 2022. Fiscal Year 2022 covers the time period from October 1, 2021 to September 30, 2022. This list also provides a comparison between the amount of funds programmed within the FY 2021-2024 Transportation Improvement Program and obligations made for specific projects.

Note on Listing of Obligations within Grouped Work Categories

The State of Texas groups several types of projects into general categories that are fiscally constrained on a statewide basis. These categories generally cover preventative maintenance, rehabilitation, bridge replacements / rehabilitation and other miscellaneous projects that do not fit within a specific category. Expenditures within these categories are based upon need, which may arise suddenly due to acts of nature, crash damage, etc. Due to the nature of these types of projects, the Waco MPO participates within the grouped CSJ program for the Transportation Improvement Program and as such individual projects within these categories are automatically approved by the MPO Policy Board within the TIP. Nevertheless, the MPO identifies each project obligation within the grouped work categories for this document.
