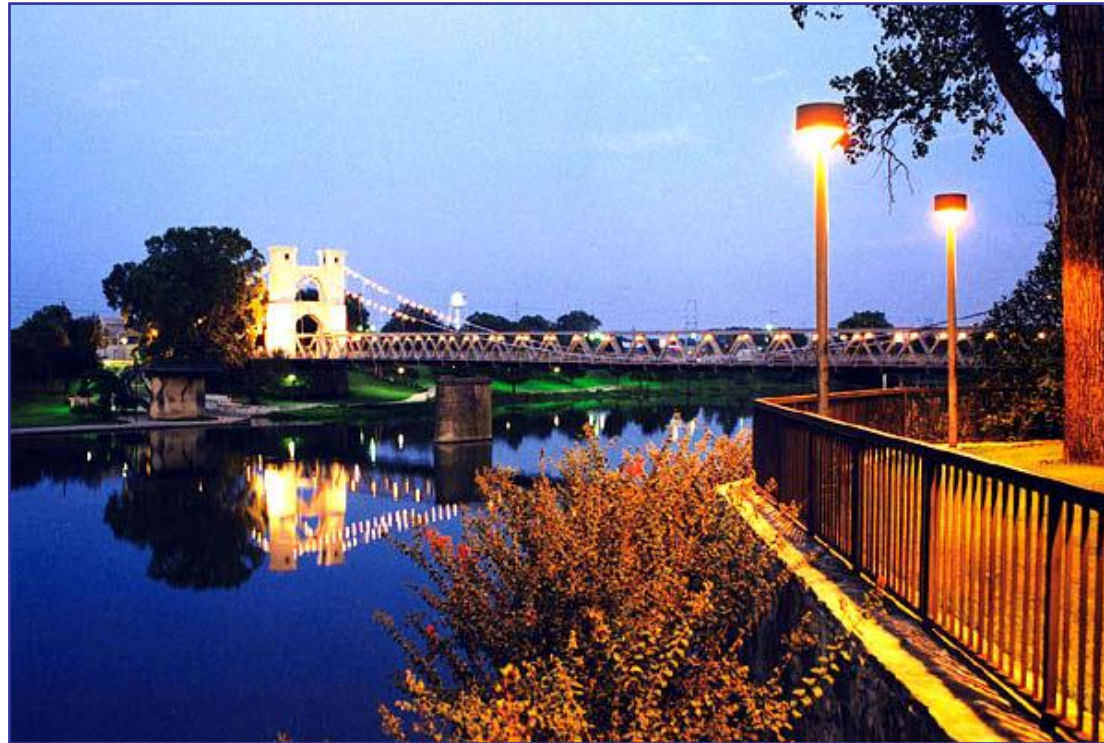

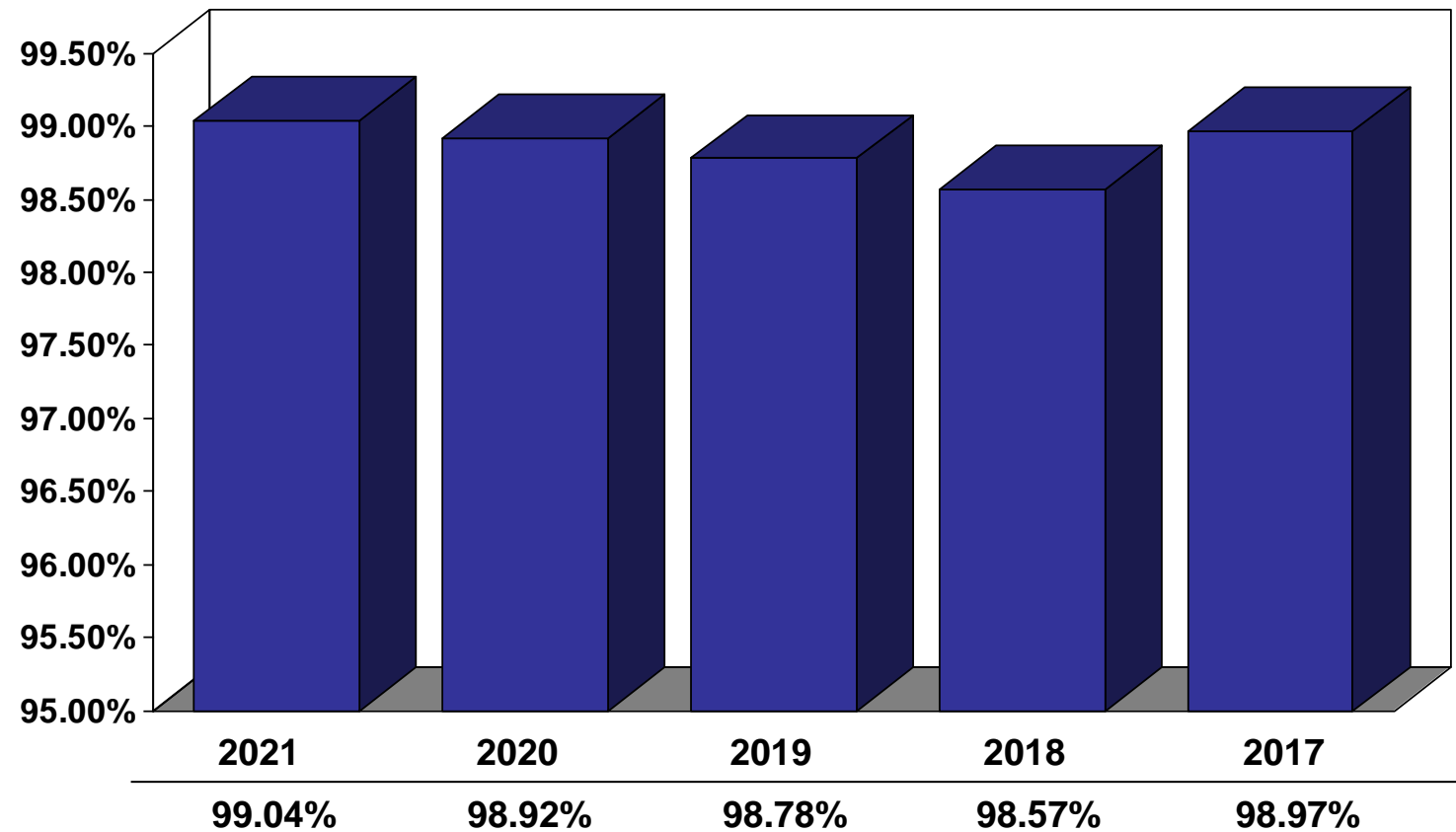

CURRENT TAX COLLECTIONS



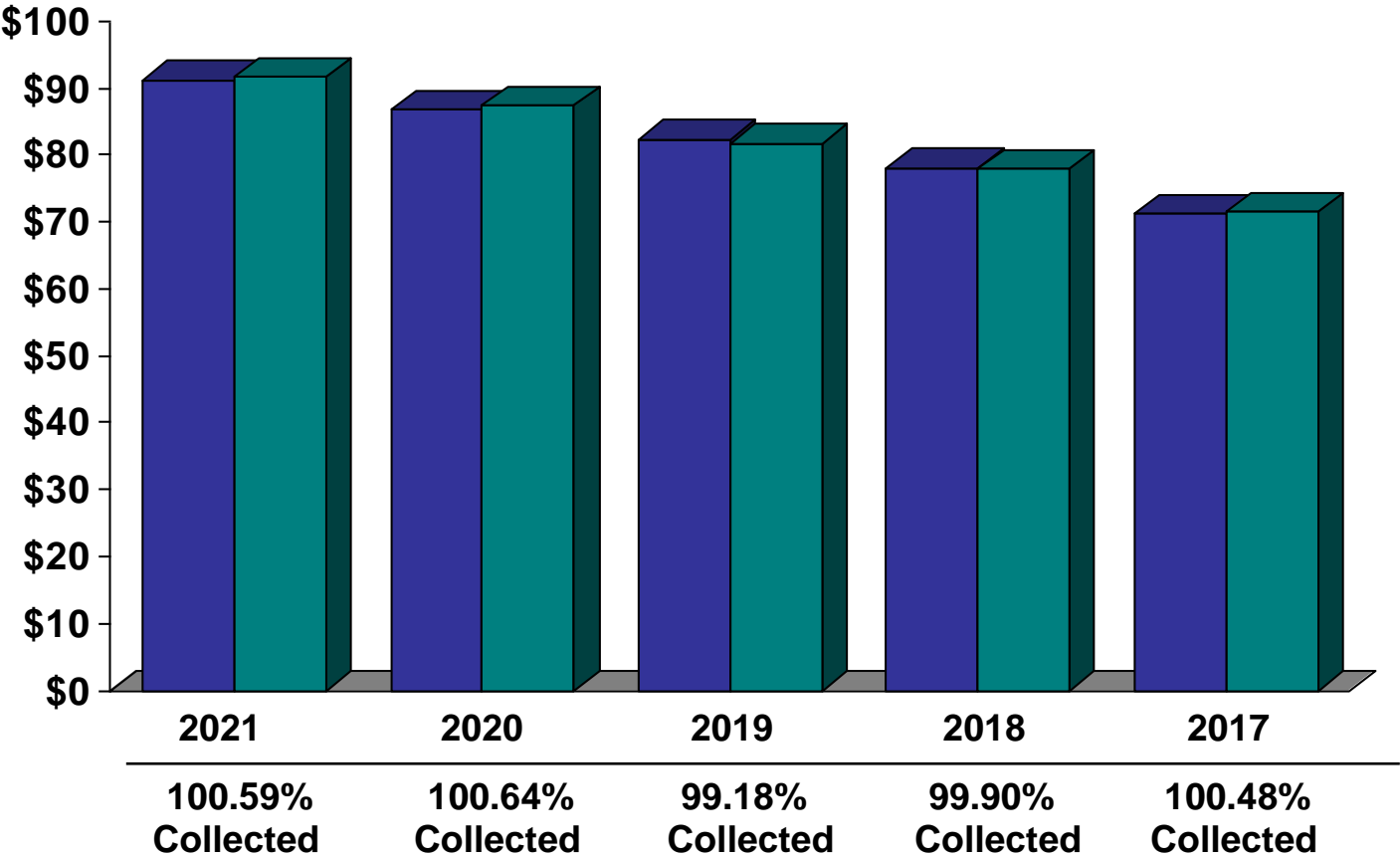

Millions

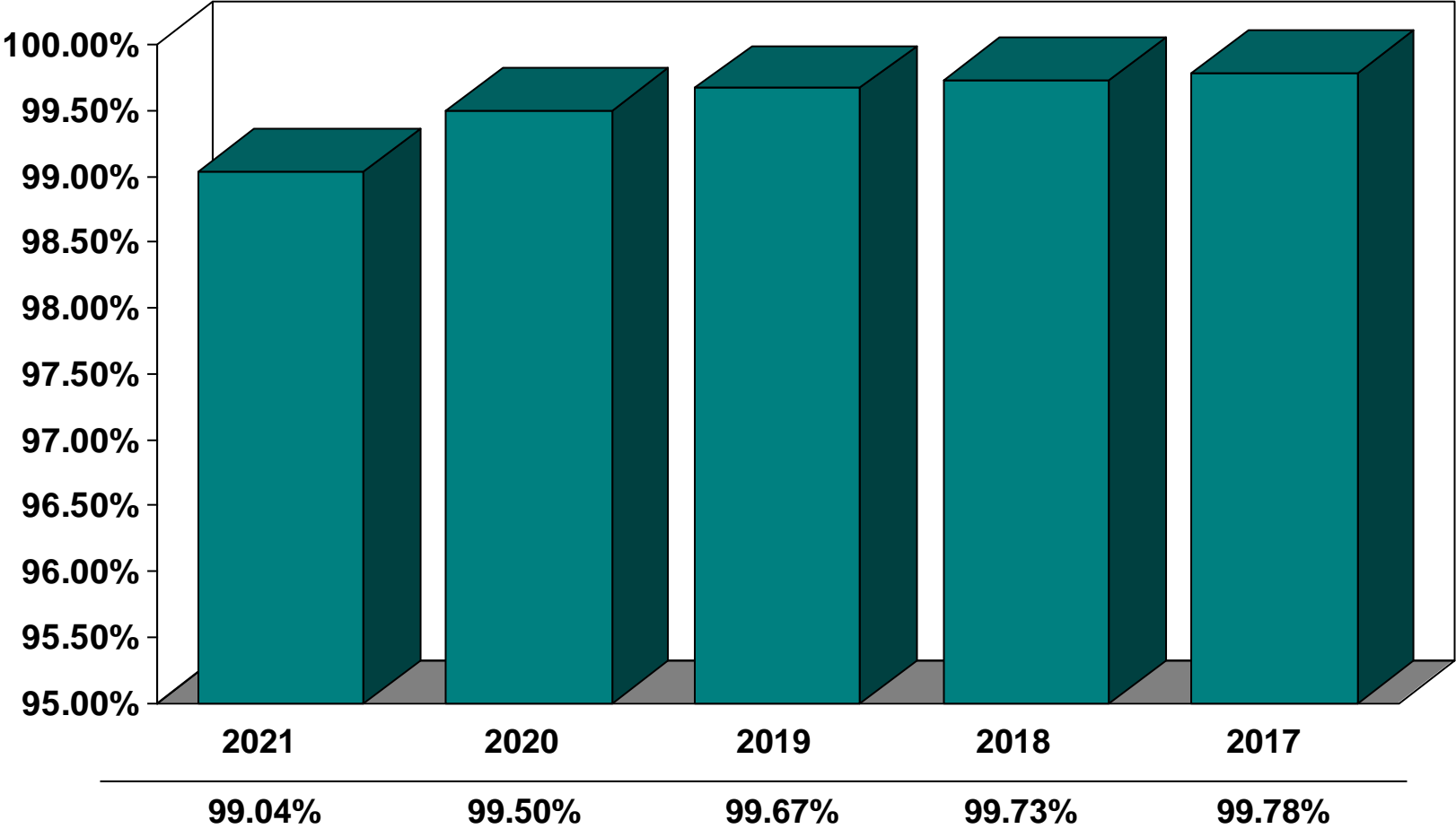

COLLECTION OF LEVY



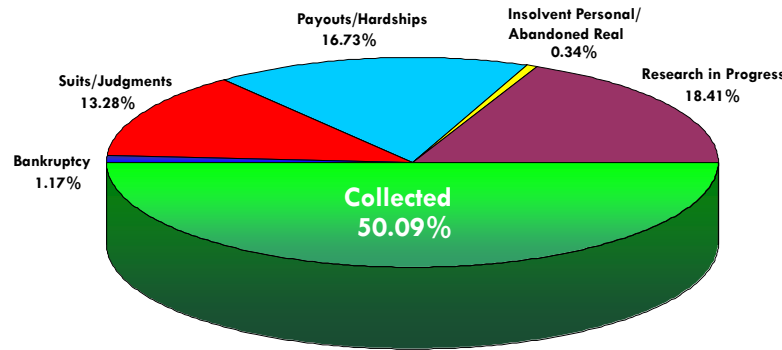

STATUS OF DELINQUENT TAXES

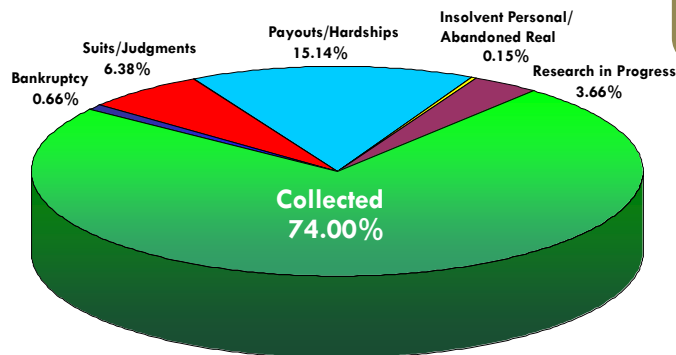
2021 Delinquent Taxes

2020 Delinquent Taxes

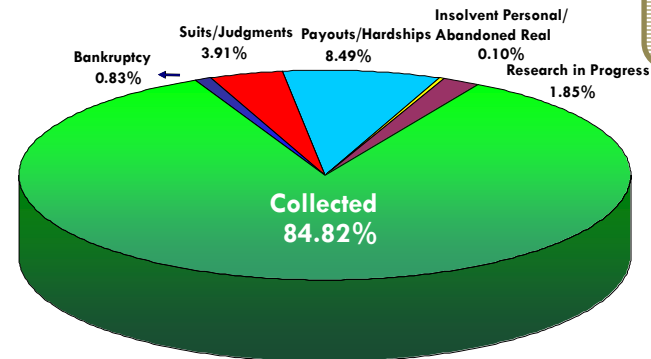

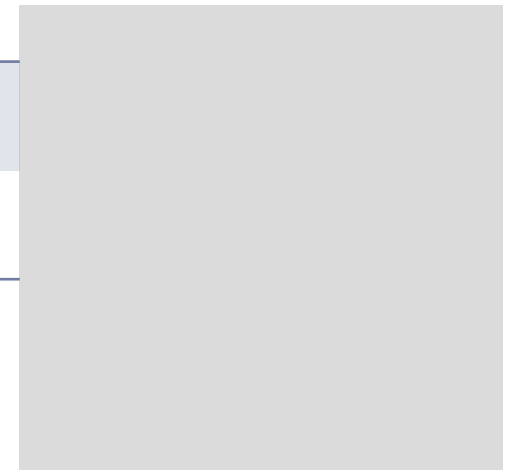
