Consider an ordinance amending various sections in Chapter 28 – Zoning of the Code of Ordinances of the City of Waco, Texas, for the purposes of adding a definition for House Museum, determining the zoning districts in which House Museum will be allowed as a permitted use or by special permit and providing parking requirements for such use.

Chapter 28 - ZONING

ARTICLE 1

Section 28-1. Definitions.

<u>House Museum- shall mean a property designated as a Recorded Texas Historic Landmark</u> ("RTHL") with historic or architectural significance which provides house tours to be conducted for compensation to the public for the purpose of offering varied experiences for education. enjoyment, reflection and knowledge sharing.

Allowed by special permit use in: R-1A, R-1B, R-1C, R-2, R-3A, R-3B, R-3C, R-3D, and R-3E zoning districts

Allowed as a permitted use in:

O-1, O-2, O-3, C-1, C-2, C-3, C-4, and C-5 zoning districts, and

Providing parking requirements:

- -1 space per 400 square feet or
- -1 space per 3 persons on a tour if limited to tours only
