### **History of the Health District**





#### Waco-McLennan County Health Unit

City of Waco & McLennan County began jointly funding Indigent Health Hospital and the Health Unit

### Health District Created

"Local Public Health Reorganization Act"

Cooperative Agreement Established between City of Waco & McLennan County

Fully funded by the City of Waco



#### Member Cities Added

Cooperative Agreement amended to include additional jurisdictions in McLennan County

Still only funded by City of Waco



#### OSSF Program Created

McLennan County began funding the OSSF program

### History of the Health district (cont'd)





#### Pilot Site for Population Health

The Health District was selected by DSHS as a pilot site to model the population health approach in local public health.

#### **Primary Care Shifted to WFM**

Pre-natal and well-child primary care services were shifted to Waco Family Medicine.



#### Dental Clinic Closed

The Dental Clinic operated within the Health District closed and service were transferred to Waco Family Medicine.

# 10 Essential Public Health Services & TX Health & Safety Code


- 1. Assess and monitor population health status, factors that influence health, and community needs and assets
- 2. Investigate, diagnose, and address health problems and hazards affecting the population
- 3. Communicate effectively to inform and educate people about health, factors that influence it, and how to improve it
- 4. Strengthen, support, and mobilize communities and partnerships to improve health
- 5. Create, champion, and implement policies, plans, and laws that impact health
- 6. Utilize legal and regulatory actions designed to improve and protect the public's health
- 7. Assure an effective system that enables equitable access to the individual services and care needed to be healthy
- 8. Build and support a diverse and skilled public health workforce
- 9. Improve and innovate public health functions through ongoing evaluation, research, and continuous quality improvement
- 10. Build and maintain a strong organizational infrastructure for public health

The <u>10 Essential Public Health Services</u> provide a framework for public health to protect and promote the health of *all people in all communities*.

- Chapter 122. Powers and Duties of Counties and Municipalities Relating to Public Health



### **Public Health Services Through the Lifespan**




### **WMCPHD Staff Funding Breakdown**

- Grant Funded = 7





### **Proposed Language Changes to HD Cooperative Agreement**

Section	Proposed Changes
2.2, 4.1 – Health Board	Clarifies Board's advisory role to reflect the Texas Health and Safety Code
4.5 - Terms	Included staggered terms and term length
4.7 – Quorum	Increased quorum to majority of Government Representatives present
4.8 – Meetings	Director and Health Board Chair can call Special Meetings

### **Proposed Language Changes to HD Cooperative Agreement**

Section	Proposed Changes
4.10 – Residency	Included 3-year residency requirement in District
7.6 – Approval of expenditures; bidding requirements	Increased Director's spending authority from \$25,000 to \$50,000.
7.10 – Audit	Changed from mailing paper copies to providing electronic versions of the financial report.

### **Recommended Changes from Advisory Board Members**

Section	Proposed Change
4.2.1 Composition	Omit the wording reference who will serve from the county and insert generic language about appointments.
4.8 Meetings	Retain the wording, "Special meetings may also be called by Government Representatives."
