Waco October 2021 Sales Tax Report

Background

The sales tax information is provided monthly by the Texas Comptroller. The sales tax information is reported 2 months in arrears, and therefore the October report is August actual sales tax figures.

The city collected \$3,987,666 for sales in August 2021. This amount is a record collection for the month. This is the first collection of the fiscal year. This amount is \$460,419 or 13.05% higher than the budgeted amount, and \$628,742 or 18.7% higher than last year.



Sales Tax Forecast

The October report (August sales) is the first report of the 2022 fiscal year. The budget staff expects sales tax collections in the city to return to pre-pandemic levels, increasing 3% to 6% year over year as the population and number of businesses increase. As a result, the budget staff has budgeted \$43,600,094 for the 2022 fiscal year. However, the budget staff monitors sales tax collections throughout the year, to make any adjustments. The forecast is based on historical actuals and the current month collection. Therefore, if a month is above average the forecast will show a higher year end forecast. If a month collection is below average, then the forecast will decrease.

The amount in the October report, represents a record high collection. As a result of this and the most recent data, the forecast model is showing a significantly higher amount compared to the budget. With only one month of data, it is far too early to determine and to make an accurate forecast for the fiscal year. As we progress through the fiscal year and collect more data, the budget staff expects the plotted lines to come closer together to have a more accurate forecast.



(i) Correlation is the multiplier used based on what has been collected throughout the year to help generate a forecast.
