Purpose for Amendment 1

1.1 Background

The 2021-2024 Transportation Improvement Program (TIP) was adopted by the MPO Policy Board on June 18, 2020. The adopted TIP programmed \$130 million in highway projects for the 4-year time period. At the time of adoption, MPO staff advised the Policy Board to expect changes to projects programmed in the TIP due to revenue decreases being observed as a result of COVID-19 economic impacts.

During the middle of August 2020, MPO staff was informed that the Statewide TIP was overprogrammed by several billion dollars in highway projects. According to the Transportation Planning and Programming Division of TxDOT, the Waco MPO needed reduce highway expenditure within TxDOT Category 2 to \$50 million over the 4 fiscal years within the TIP in order to remain fiscally constrained. This is a reduction of \$70 million in Category 2 availability for the duration of this TIP. In response, the Policy Board directed staff to prepare amendments to the 2021-2024 TIP that would program \$68.4 million in highway projects for the 4-year time period, a reduction of \$61.6 million.

In early October 2020, the Transportation Planning and Programming Division of TxDOT instructed the Waco MPO to adhere to a requested \$70 million reduction in highway project cost from the 2021-2024 TIP in order to remain fiscally constrained. As a result, an additional \$18.4 million in projects would need to be postponed to beyond fiscal year 2025 in order to remain fiscally constrained. This amendment identifies the final project programming for the TIP using TxDOT Category 2 funds.

1.2 Project Selection

Project recommendations identified within this amendment are intended to reprioritize highway projects in order to remain fiscally constrained. These recommendations are depicted on Map 4 and Appendix D Map.

Projects scheduled for construction during fiscal year 2021

One project scheduled for construction during fiscal year 2021 is recommended for inclusion as adopted by the MPO Policy Board on June 18, 2020:

1. SH 31 at FM 939 intersection - Construct overpass

Projects recommended for construction in a different fiscal year

The Waco MPO was notified by the TxDOT Waco District Headquarters in August 2020, that one project scheduled for construction in fiscal year 2023 can be implemented in fiscal year 2022. This project is now recommended for inclusion in FY 2022 with a TxDOT recommended incentive package of \$2.0 million for expedited completion:

 SH 6 / W Loop 340 from US 84 to IH-35 (Mall to Mall project) – Construct continuous frontage roads, reconstruct main lane overpasses over Union Pacific Railroad tracks and realign on & off ramps

Projects recommended for removal from the FY 2021-2024 TIP

- 1. IH-35 from Valley Mills Dr to Irving Lee St Construct continuous frontage roads
- 2. IH-35 from Irving Lee St to south of New Rd Reconstruct frontage roads, Realign on and off ramps, Reconstruct main lane overpass at New Rd
- 3. SH 6 from Lady Bird Rd to Spur 412 (McLaughlin Rd) Widen to 4 lanes with center turn lane
- 4. FM 2113 (Spring Valley Rd) from FM 2063 to FM 1695 Construct center turn lane, shoulders and curb and gutter
- 5. SH 31 at FM 2311 intersection Construct Overpass

<u>Projects recommended for Appendix D</u>

Appendix D contains projects that are scheduled for implementation beyond the four years of the TIP time frame and may be under some phase of development as identified within the TxDOT Unified Transportation Program. The projects are included to recognize some commitment on the part of the Waco MPO Policy Board to implement these phases of work at a future date pending a formal commitment of funding. Note: inclusion of a project or phase of work within Appendix D in no way implies that these projects are programmed in the current TIP. Cost estimates are preliminary and do not represent any current commitment of construction funding.

In addition, because the IH-35 Breakout projects from Valley Mills Dr to south of New Rd are recommended for removal from the <u>FY 2021-2024 TIP</u>, the entire scope of work for IH-35 reconstruction south of 12th Street is included which incorporates the work for the breakout projects.

Projects recommended for implementation beyond fiscal year 2024:

- SH 6 from Lady Bird Rd to Spur 412 (McLaughlin Rd) Widen to 4 lanes with center turn lane
- 2. IH-35 from South 12th St to South Loop 340 Widen to 8 main lanes and reconstruct to current interstate standards
- 3. FM 2113 (Spring Valley Rd) from FM 2063 to FM 1695 Construct center turn lane, shoulders and curb and gutter
- 4. SH 31 at FM 2311 intersection Construct Overpass
