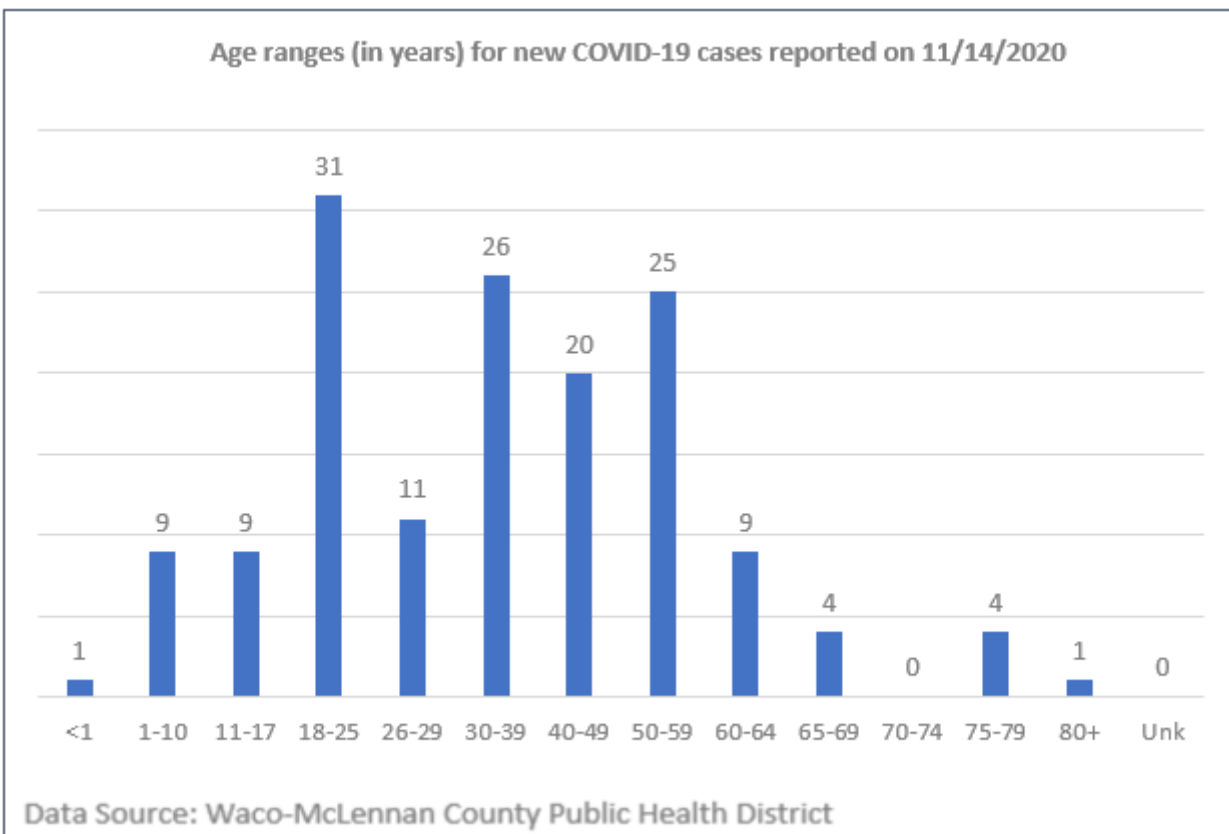

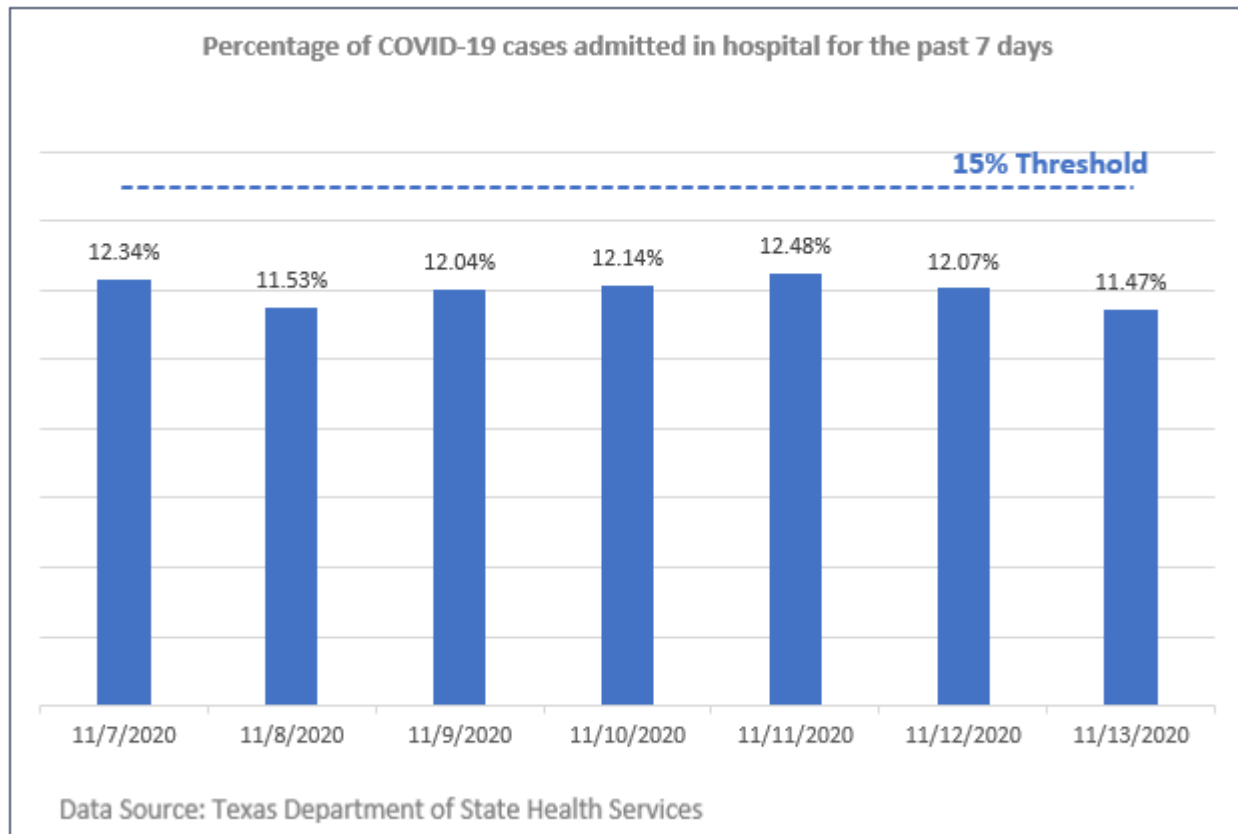
- 150 New Cases of COVID-19
- No New Deaths Attributed to COVID-19
- Next TWO days free testing locations

(November 14, 2020) One hundred and fifty new cases of COVID-19 are confirmed as of today. Seventy-five of the cases are reported from surge testing. The total number of cases to date is 12,106. There are 1,169 estimated active cases, and 10,769 estimated cases who have recovered. Sixty-one cases are hospitalized. Of the 61 hospitalized, 42 cases are McLennan County residents. Ten are on ventilators. The total number of deaths is 168.

As of November 13, 2020, the hospitalization rate is 11.47% for Trauma Service Area M, as calculated by Texas Department of State Health Services (DSHS).



Executive Order GA-32 allows restaurants and other venues to reopen at 75% capacity and allows elective surgeries if the hospitalization rate in a Trauma Service Areas (TSA) with a COVID-19 hospitalizations rate under 15% over a seven-day period. If the hospitalization rate goes over 15% for seven consecutive days, venue capacity will be lowered to 50% and elective surgeries will be postponed until further notice.
