Do you walk, ride, roll, bike, ride a bus or drive in McLennan County? The Waco region is growing! That raises questions about how we will get to places we want to go now and in the future.

Connections 2045: The Waco Metropolitan Transportation Plan (MTP) outlines mobility needs for the Waco Metropolitan Area through 2045. The MTP serves as the blueprint from which transportation projects to address those needs are developed. The draft MTP is complete and ready for public review and comment. The draft document may be viewed on the MPO website at www.waco-texas.gov/cms-mpo under the page for plans and programs.

In addition to the MTP, the Waco MPO will also be soliciting comments for preliminary recommendations for the Fort Worth to Laredo High Speed Transportation Study.

The MPO will be conducting 2 public informational meetings in December to share the draft MTP and High Speed Transportation Study and to solicit comments regarding proposed recommendations. These meetings are scheduled as follows:
