WACO – The Waco Metropolitan Planning Organization (MPO) is soliciting comments regarding proposed amendments to Connections 2045: The Waco Metropolitan Transportation Plan (MTP) and on the draft 2021-2024 Transportation Improvement Program (TIP).

The MTP outlines the broader mobility needs for the Waco Metropolitan Area through 2045 and serves as the blueprint from which mobility projects to address those needs are developed. The TIP is a list of federally funded highway or transit projects scheduled for implementation within the Waco Metropolitan Area during fiscal years 2021 to 2024. Two public informational meetings will be conducted virtually by conference call to provide information regarding these documents and to accept comments from the public.
