The Waco Metropolitan Planning Organization (MPO) is now receiving public comment on proposed amendments to Connections 2040: The Waco Metropolitan Transportation Plan (MTP) and proposed travel time reliability performance targets.

The Waco Metropolitan Transportation Plan (MTP) outlines the transportation needs for the metropolitan area through the year 2040 and the projects required to address the projected needs. The Fixing America's Surface Transportation (FAST) Act identifies new requirements for the transportation planning process that must be incorporated or addressed into the MTP. The Waco MPO is proposing amendments to the MTP in accordance with these requirements and is soliciting public comment regarding the proposed amendments.

Transportation Performance Management (TPM) is federally required by Congress through the FAST Act. It is a strategic approach that uses goals, measures, and data to make better informed decisions about how to invest transportation funding aimed at a better performing national transportation system. The Waco MPO is proposing region specific travel time reliability performance targets in accordance with these requirements and is soliciting public comment regarding them.

The MPO will be conducting 2 public informational meetings to give interested persons the opportunity to view the draft recommendations and to solicit comments regarding these recommendations. The meetings are scheduled as follows:
