The proposed tax abatement agreements concern the following:

1. **Agreement #1**

Name and Location of the Reinvestment Zone In Which the Property Subject to the Agreement is Located: Waco Reinvestment Zone Number Seventy (70), City of Waco, created by Ordinance No. 2019-870 on November 5, 2019, being an approximately 16.89 acres of land located at Block 6, Lot 12, Texas Central Addition to the City of Waco, McLennan County, Texas, situated in the Carlos Ocampo Survey, Abstract No. 32 and located within Census Tract 37.06, Block Group 1.

General Description of the Nature of the Improvements or Repairs: Timber US Inc. will invest at least \$8,245,000.00 in real property improvements for its heavy haul trailer manufacturing business, which will include offices, sales, and an approximately 54,000 sq. ft. warehouse with its tenant, Aspen Custom Trailers US Inc.




