To the registered voters of the County of McLennan, Texas:

Notice is hereby given that the polling places listed below will be open from 7:00 a.m. to 7:00 p.m., May 2, 2020, for voting in a Joint General Election:

- to elect one (1) person for each position to serve the full term of two (2) years for three (3) positions (SMD 3, SMD 4 and an at-large position) for the City of Bellmead;
- to elect one (1) person for each position to serve the full term of two (2) years for Mayor (Place 1) and two (2) positions (Place 5 and Place 6) for the City of Gholson;
- to elect one (1) person for each position to serve the full term of two (2) years for three (3) positions (Ward 1, Place 2; Ward 2, Place 2 and Ward 3, Place 2) and a Special Election for an unexpired term for one (1) position (Ward 2, Place 1) for the City of Hewitt;
- to elect one (1) person for each position to serve the full term of two (2) years for three (3) positions for the City of Mart;
- to elect one (1) person for each position to serve the full term of two (2) years for Mayor and two (2) positions for the City of McGregor;
- to elect one (1) person for each position to serve the full term of two (2) years for Mayor and two (2) positions (SMD I and SMD III) for the City of Waco;
- to elect one (1) person for each position to serve the full term of three (3) years for two (2) positions on the Board of Trustees for the Crawford Independent School District;
- to elect one (1) person for each position to serve the full term of three (3) years for two (2) positions (Place I and Place II) on the Board of Trustees for the Midway Independent School District;
- to elect one (1) person for each position to serve the full term of three (3) years for two (2) positions (SMD 3, Place 3 and an at-large Place 7 position) and a Special Election for an unexpired term for one (1) position (at-large Place 6 position) for the Board of Trustees for the Waco Independent School District.

The execution of a Joint Election Agreement with Bellmead, Gholson, Hewitt, Mart, McGregor, Waco, Crawford ISD, Midway ISD and Waco ISD is hereby authorized and approved.
