

**Correction to Notice to the Public of 30-Day Comment Period  
Substantial Amendment to the 2015, 2017, 2018, 2019, 2020, and 2021 Annual Action Plan  
for the Community Development Block Grant Program (CDBG)**

In accordance with the City of Waco's (COW) Citizen Participation Plan and requirements of the U.S. Department of Housing and Urban Development (HUD), a 30-day comment period is required when making a substantial amendment to the Annual Action Plan. The substantial amendment will result in allocating earned program income to an assigned project. The proposed project is the acquisition and rehabilitation of an affordable housing property for rental to a low-to moderate income household. **The 30-day comment period will begin June 17, 2022, and end July 19, 2022.** There will be an opportunity for the public to submit written comments on the project.

The City of Waco has determined that it is necessary to amend the approved PY 2015, 2017, 2018, 2019, 2020 and 2021 Annual Action Plans to meet the needs of citizen comments and concerns. In accordance with Federal CDBG and HOME Program regulations, 24 CFR 91.105(c) and 24 CFR 91.505, the City is allowed to make substantial amendments to its Annual Action Plan, Consolidated Plan and Budget in accordance with the Citizen Participation Plan.
