What is the Metropolitan Transportation Plan (MTP)?

- Required by 23CFR450
- Identify regional transportation goals
- Identify projects to be constructed or implemented by 2045
 - Projects that help achieve plan goals
 - Includes regionally significant projects from each mode
 - Highways, Public Transportation, Aviation, Rail
 - Inclusion required for federally funded highway & transit projects
- Projects must be constrained against a realistic estimate of future revenues


Project Strategy 1: Improve State of Good Repair

- Guiding Principle: Satisfactorily Maintain Existing Facilities
- Categorical Projects
 - Routine Preventative Maintenance & Rehab
 - Highways
 - \$1.021 billion
 - Transit
 - \$59.9 million

Strategy 1 – Improve State of Good Repair




Project Strategy 2: Improve Safety and Security

- Categorical Projects
 - Highway Safety
 - \$25.0 million




Project Strategy 3: Improve System Efficiency


Project Strategy 4: Improve Regional Livability

- Guiding Principle: Preserve Regional Air Quality and Environmental Standards
- Categorical Projects
 - Bicycle Corridors
 - \$14.6 million
 - Pedestrian Corridors
 - \$16.4 million

- Guiding Principle: Support Regional Freight Movement and Economic Development Efforts


MTP Recommendations

Strategy 5 – Address Demand for Future Mobility

- Interstate 35 – A Change in Strategy
 - 2 breakout projects prior to 2030
 - Southbound on / off ramp realignment between Valley Mills Drive and Loop 340 & replace bridges over New Rd
 - Reconstruct interchange with frontage roads and Valley Mills Drive
 - Remaining work between 12th Street and Loop 340 would be scheduled after 2031

- Guiding Principle: Improve Access to Economic Opportunities and Essential Services




- Transit Categorical Projects
 - Urban Fixed Route Operations through 2030
 - \$28.2 million
 - ADA Paratransit
 - \$14.6 million
 - Rural Transportation
 - \$3.5 million
 - Elderly / Disabled Transportation
 - \$2.5 million

Strategy	Total Cost	Percent of Plan
1 – State of Good Repair	\$1,239.0	55.5%
2 - Safety	\$59.1	2.6%
3 - Efficiency	\$97.6	4.4%
4 - Livability	\$47.85	2.1%
5 - Mobility	\$551.2	24.7%
6 – Equity	\$237.1	10.6%
Total Plan	\$2,231.85	100.0%
