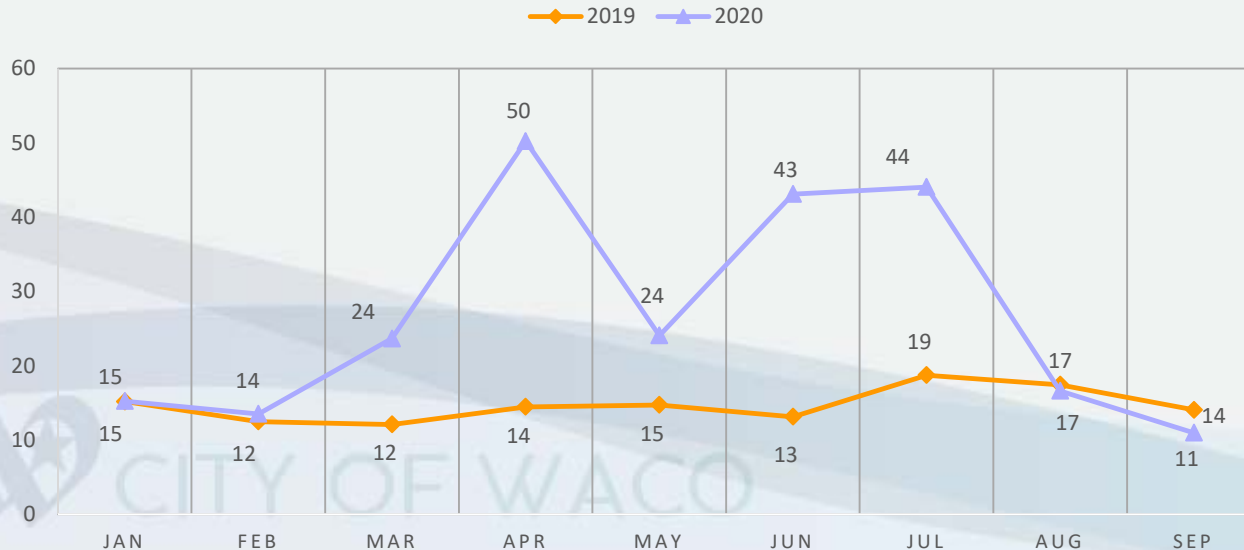
NUMBER OF EDO REPORTS

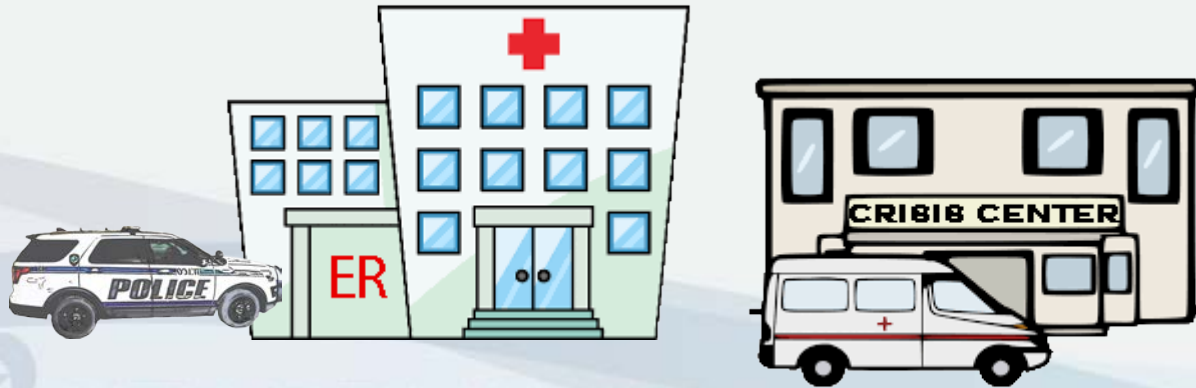
