A copy of the application may be obtained from the City Secretary's office or Waco-Texas.gov</p> <p>b) CITY OF WACO HOME RULE CHARTER REQUIREMENTS: [See Sec. 141.003(a)] 1) Citizen of United States, 2) 21 years of age, 3) Qualified voter of the State and City for 12 months immediately preceding the date of election, 4) If elected from a district, a resident of the district for six months preceding the date of election.</p> <p>c) Candidate will file application with City Secretary designating office sought and sworn statement by the candidate that they are fully qualified under the Laws of the State of Texas and the provisions of the Charter.</p> <p>d) Election code permits a Home Rule Charter to prescribe a minimum age of not more than 21 years [Art. II, Sec. 3; Art.
